CONDITIONS OF NOMINATION AND ELECTION

CONDITIONS FOR NOMINATION AND ELECTION

- 1. Nominations are called for the positions of Vice President, Treasurer and three ordinary members.
- 2. Only a FINANCIAL Member (either an individual Member or the authorised representative of an institutional Member) or those willing to become a Member, can stand for election or nominate for the above positions.
- 3. Nominations are to be received <u>NO LATER THAN 5PM FRIDAY 17 AUGUST</u> responsibility of Nominees to ensure that nominations have arrived on time.
- 4. Where applicable, this nomination and election is subject to the constitution and rules of Museums Galleries Australia Inc and the by-laws of the Western Australian branch of Museums Australia Inc.
- 5. If there is more than one nomination each for vacant Executive positions a ballot will be conducted in line with the requirements of the constitution, rules and by-laws.
- 6. The ordinary Members of the Committee will be elected at the AGM and will hold office for a term of two years. Normally no person will be a Member of the Committee for more than four consecutive terms and no ordinary Member for more than three consecutive terms.
- 7. Any nomination not properly executed, or not complying with these conditions, will be declared invalid.
- 8. If there are more than four nominations for ordinary Members a ballot will be conducted in line with the requirements of the constitution and the by-laws.
